Supercharging the economy

- Finalise the draft Cape York Regional Plan for statutory public consultation.
- Pass the new Regional Planning Interests Act to protect prime agricultural land and strategic environmental areas.
- Release the Expressions of Interest document for the Queens Wharf Redevelopment.
- Release Governing for Growth, a whole of Government economic strategy.
- Conduct targeted trade missions to foster greater trade relations and assist Queensland businesses to directly establish contacts in overseas markets.
- Appoint the inaugural ASEAN (Association of South East Asian Nations) Trade Commissioner who will be based in TIQ's new office in Indonesia.
- Release the Newman Government's two year anniversary red tape Report Card.
- Announce the successful applicants for the second round of *Supporting Women Scholarships*, designed to help women of all ages and backgrounds gain qualifications in traditionally male-dominated industries.
- Deliver a strategy for growing Queensland's international education industry.
- Introduce amendments to Queensland's workplace health and safety legislation, to reduce red tape.
- Finalise the Parliamentary inquiry on options to increase agriculture and livestock freight on rail.
- Commence Parliamentary inquiry to investigate the feasibility of coastal shipping between Queensland ports.
- Finalise the speed limit review for 100 nominated roads across the State.
- Finalise funding negotiations with the Abbott Government on the Outback Highway between Laverton in Western Australia to Winton in Western Queensland.
- Commence implementation and training in preparation for the safety and security of the G20 summit.
- Develop an interactive tool to help councils use the Queensland Land Audit in their planning decisions.
- Commence implementing the 'Growing the Agriculture Workforce Strategy' aimed at helping industry attract, retain and develop people in farm industries.
- Finalise the report for Queensland's foot and mouth disease preparedness capability.

- Continue to provide assistance to Queensland producers in drought-declared areas of the state.
- Continue the Inshore Net Fishery Buy Back Scheme to increase sustainability and profitability of Queensland's fisheries.
- Renew the Queensland Alliance for Agriculture and Food Innovation (QAAFI) partnership agreement.
- Finalise the State of Queensland Agriculture report for consultation by industry.
- Replace wild river declarations for Cape York and Western Rivers.
- Provide the resources sector greater certainty and consistency through the introduction of model conditions for petroleum and gas production.
